From time to time you may have to deal with children with a range of special needs; the headteacher and teaching staff will advise you.

It is the responsibility of the lunchtime supervisor to support children throughout the lunchtime period by helping them to:

- get ready for lunch go to the toilet and wash their hands
- select cutlery
- eat their lunch opening packets, cutting food etc.
- create a happy and relaxed 'family style' lunchtime experience
- engage in conversations and interactions with their peers and the adults
- play happily outdoors, except on wet days when it will be necessary to read stories and play quiet games indoors

After the children have finished eating, on a rotational basis it will be necessary to help clean the tables and sweep the floor.

All lunchtime staff are expected to work supportively in a team, aiming to make the lunchtime period a happy and settled time for all children.
